Summary of Bylaws Pertaining to the Annual Meeting

Any natural person, firm, association, corporation, business trust, partnership or body politic shall be eligible to become a member of, and, at one or more premises owned or directly occupied or used by him, to receive service from Jones-Onslow Electric Membership Corporation. No person shall hold more than one membership in the cooperative

An Annual Meeting of the members, for the purpose of electing directors, hearing and passing upon reports covering the previous fiscal year, and transacting such other business as may properly come before the meeting, shall be held on the last Friday of the month of March of each year. Provided, that for good cause, the Board of Directors may fix a different date for such Annual Meeting not more than thirty (30) days prior or subsequent to the date established for such meeting in this Section.

Attendance in person of at least two percent (2%) of the then total members of the cooperative shall be required for the transaction of business at any meeting of the members. If less than a quorum is present at a meeting, a majority of those present in person may adjourn the meeting to another time and date.

The election of directors shall be completed at each legal meeting by the members. The business and affairs of the cooperative shall be managed by a Board of ten (10) Directors, which shall exercise all the powers of the cooperative except such as are by law or by the cooperative's Articles of Incorporation, or Bylaws conferred upon or reserved to the members.

The Board of Directors shall consist of ten (10) Directors. One (1) of the cooperative's Directors shall be elected on an "At-Large" basis and may reside anywhere within the Cooperative service territory. The other nine (9) directors shall be nominated and elected so that at least three (3) but not more than four (4) shall be residents of each of the Cooperative's three (3) Directorate Districts, which are as follows: District Number One--those areas served by the Cooperative in Pender, Onslow, Carteret and Craven counties and which lie on the eastern side of U.S. Highway No. 17; District Number Two--those areas served by the Cooperative in Duplin County and in Pender and Onslow counties on the western side of U.S. Highway No. 17; and District Number Three--those areas served by the Cooperative in Lenoir County and Jones County, and the western side of U.S. Highway No. 17 in Craven County. The one (1) "At-Large" Director shall be elected on an "At-Large" basis and may be a resident of any of the foregoing three geographic Directorate Districts, even if the result is to give one District more than four Directors.

Nominations. It shall be the duty of the Board to appoint, not less than fifty (50) nor more than one hundred fifty (150) days prior to the date of a meeting of the members at which directors are to be elected, a Nominating Committee, consisting of three (3) members from each of the Cooperative's three (3) directorate districts, and who (a) are not existing Cooperative employees, agents, officers, directors or known candidates for directors; and (b) are not close relatives or members

of the same household of any such person. Only those directors not up for election shall be eligible to participate in the nomination, voting, and ultimate appointment of the Nominating Committee. The Nominating Committee shall serve three (3) year terms and shall not be permitted to serve consecutive terms. Members may be reappointed to the Nominating Committee so long as they do not serve two (2) consecutive terms. This Committee shall be appointed so that three (3) members are appointed and consist of one (1) member from each of the Cooperative's three (3) directorate districts and the following year three (3) members are appointed consisting of one (1) member per directorate district and so on. In the event that a member of the Nominating Committee is unable or unwilling to serve a full three (3) year term then the Board shall appoint a replacement to fulfill the unexpired term created by the vacancy. In such cases the new appointee shall be eligible for re-election at the conclusion of the unexpired term. The Committee shall meet in person in one of the counties in which the Cooperative serves or a meeting may be authorized to enable member participation through an electronic format under circumstances determined by the CEO of JOEMC (see footnote 1). The Committee shall prepare and post at the principal and all district offices of the Cooperative, at least twenty (20) days before the meeting, a list of nominations for directors to be elected, listing separately the nominee(s) for each directorate district from which a director must or may, pursuant to this article, be elected at the meeting. The committee may include more nominees than there are to be elected, but it shall show clearly which nominees are opposed with respect to the same directorate district, or as between two or more districts; provided, it shall not make a nomination until it shall have first determined that the nominee is qualified to serve in accordance with the provisions of Section 4.02 and, if elected, will serve. Any one half of one percent (.5%) or more members of the Cooperative, acting together, may make additional nominations in writing over their signatures, listing their nominee(s) in like manner and filing the same with the Cooperative not less than thirty-five (35) days prior to the meeting; and the Secretary shall post such nominations at the same places where the list of nominations made by the Committee is posted. The Secretary shall mail to the members with the notice of the meeting, or separately, but at least fourteen (14) days prior to the date of the meeting, a statement of the names and addresses of all nominees, showing clearly those nominated by the Committee and those nominated by petition, if any. The Secretary shall include, if requested, in such mailing a brief (250 words or less) prepared biography of a nominee and/or advertisement for the election of the nominee which shall be authorized by the nominee in writing or by the initials of the nominee. All nominations, however made, shall specify the particular Directorate District for which the nomination is made. Notwithstanding anything in this Section, failure to comply with any of the provisions of this Section shall not affect in any manner whatsoever the validity of any action taken by the Board after its election at such

A Credentials and Election Committee of at least five (5), and no more than thirteen (13), shall be appointed by the Board at least ten (10) days before any meeting of members. It shall be the responsibility of the Committee to pass upon all questions that may arise with respect to the registration of members in person, to count all ballots cast in any election, unless delegated by the Board to an independent auditor, or in any other ballot vote taken, and to rule upon the effect of any ballots irregularly marked. The Committee's decisions on all such matters shall be final.

Each member who is not in a state of suspension, shall be entitled to one vote and no more upon each matter submitted to a vote at a meeting of the members. A member, which is an association, corporation, business trust or body politic may be present in person and vote at such meeting by and through a duly designated representative, qualified as such upon registering for the meeting. At all meetings of the members, at which a quorum is present, all questions shall be decided by a majority of the members voting thereon, in person, except as otherwise provided by law or by the cooperative's Certificate of Incorporation or Bylaws. •

Power Restoration Behind the Scenes

When the power suddenly goes out, we all want to know when the lights will return, right? Have you ever thought about how it all gets fixed? This article is here to give you a closer look at what our hardworking JOEMC lineworkers do to bring back the electricity. We'll break down their essential steps, from figuring out what went wrong to finally getting everything up and running again. So, join us as we explore the behind-the-scenes journey of our lineworkers and learn how they make sure our lights stay on.

The Outage Journey Unveiled: A Lineworker's Timeline

When An Outage Occurs:

- 1. Notification: Local lineworkers receive a call from our Operations Center with outage information to determine its scale (individual or line).
- **2. Travel:** Responding from home, lineworkers drive to the reported location, which can take time.
- 3. Identify: Lineworkers visually inspect the power lines to identify the cause, such as fallen trees, damaged equipment, or accidents, and verify if a protective device has tripped, such as fuses or breakers.
- 4. Safety Procedures: Once the cause is identified, a job briefing is performed to discuss a plan of action and identify any hazards associated with the job. Other safety measures, such as work zones and grounding procedures, are implemented to protect against backfeeding.

- **5. Repairs:** Depending on the issue, lineworkers clear obstacles and replace damaged components to ensure the infrastructure is safe.
- **6. Verification:** Once repairs are made, lineworkers guarantee the scene is safe before energizing the repaired line or equipment.
- 7. Re-energize: Lineworkers contact the Operations Center, obtain clearance, and close the protective device to restore power.

This process can vary in time, and lineworkers are dedicated to restoring power as quickly and safely as possible, understanding the impact of outages on the community.

From the first call about an outage to the final moments of restoration, a linemen's dedication ensures that our lights return, bringing comfort and normalcy to our homes.



MS. VELMA'S 'It's Just Soup'

INGREDIENTS

- 1 whole chicken plus several additional leg quarters, drumsticks or thighs
- 2 cans (28 oz.) crushed tomatoes
- 2 large onions (we used yellow and sweet)
- 2 cups white corn
- 2 cups tiny butterbeans
- 1 medium head of cabbage, shredded Salt and pepper to taste

Optional additions

2 cans (15-ounce) creamed corn

3-4 large celery stalks, diced

2 tablespoons sugar (to cut acidity of tomatoes)

DIRECTIONS

- In a large pot, bring chicken to boil in 3-4 quarts of salted water. Once boiling, cover and reduce to a low boil, cooking until tender. Be sure to cover, as you do not want the broth to cook out.
- 2. Remove chicken with a slotted spoon and cool. Once cool to the touch, remove skin, debone and shred.
- 3. Add chicken and remaining ingredients except sugar to broth. Let simmer at low boil an hour or longer until nice and rich, and flavors marry. Taste for acidity and add in small amounts of sugar until flavors seem balanced. If too thick, add a bit of broth or water for preferred consistency.
